

### **Groundwater Discharges**

NBC Rules & Regulations prohibit the discharge of groundwater

### 1.5.6 Specific Discharge Prohibitions

- A. Certain substances are specifically prohibited from being discharged into the NBC's Facilities. These prohibited substances include, but are not limited to, the following:
  - Groundwater, stormwater, and surface waters, roof runoff, tidewater, subsurface drainage, non-contact cooling water, and uncontaminated industrial process waters, unless approved by the NBC (See § 1.4 of this Part)



# When NBC Does Permit Groundwater Discharges?

- NBC projects
- RI Department of Environmental Management (DEM) suggests a company redirect discharges from a surface water to the sewer due to RIPDES non-compliance
- DEM prohibits the groundwater discharge to the river

# **Prior to Permitting**

### **Company Requirements**

- Wastewater Discharge Permit Application
- Proposed Maximum Daily Flow
- Pretreatment System Plans
- Discharge Meter Specifications
- Monitoring Well / RIPDES Permit data
- Sewer Connection Permit Application

### **NBC** Tasks

- Determine if there are capacity issues
- If proposed flow is greater than 75,000 gpd **notify** DEM of substantial change
- Review meter specs
- Review plans
- Review data
- For DEM suggestions discuss with NBC Executive Director / Deputy Director

- Solids removal
  - Frac tanks
  - Filtration
  - Hay Bales
- pH Adjustment
- TTO Treatment
  - Granulated Carbon

By virtue of Rhode Island's General Laws Title 46 Chapter 25 (Act) and in accordance with The Narragamsett Bay Commission Rules and Regulations for Use of the Wastewater Facilities (Rules and Regulations), Mr. John A. Rocchio and John Rocchio Corporation, hereinafter jointly referred to as Permittee, is hereby authorized to discharge process wastewater from the above identified facility in accordance with the terms and conditions set forth in this permit.

All discharges authorized herein must be consistent with the effluent limitations, monitoring requirements and other conditions set forth in this permit. The discharge of any pollutant not identified in this permit or any pollutant identified in this permit at a level in excess of that authorized shall constitute a violation of the permit. This permit consists of 17 pages with conditions A - T.

#### This permit becomes effective upon receipt and expires on March 31, 2028.

Noncompliance with any term or condition of this permit shall constitute a violation of the Rules and Regulations and may subject the user to an Administrative or Civil Penalty of up to \$25,000 per violation per day as defined in R.I.G.L. §46-25-25.2. Willful or criminally negligent violations shall be punishable by the aforementioned fine and/or imprisonment as defined in R.I.G.L. §46-25-25.3.

compliance with the NBC discharge limitation for Total Oil and Grease

(fats, oils, and grease).


